- B) The prospective Director should consent to a credit and law enforcement background check, should it be asked of them.
- C) The prospective Director should be a present or past member of a PNW Kiwanis Club Board of Directors.
- D) The prospective Director should have business, legal, financial, accounting, philanthropy or community administration experience.
- E) The PNWKF Board should have representation from each of the PNW Regions and consequently, the Committee should search for individuals that would ensure that geographical consideration is satisfied. The Board shall not consider multiple applications from a single household.
- F) The prospective Director should be able to receive and send electronic correspondence (such as PDF (Adobe) format) and the ability to participate in real time electronic meetings.
